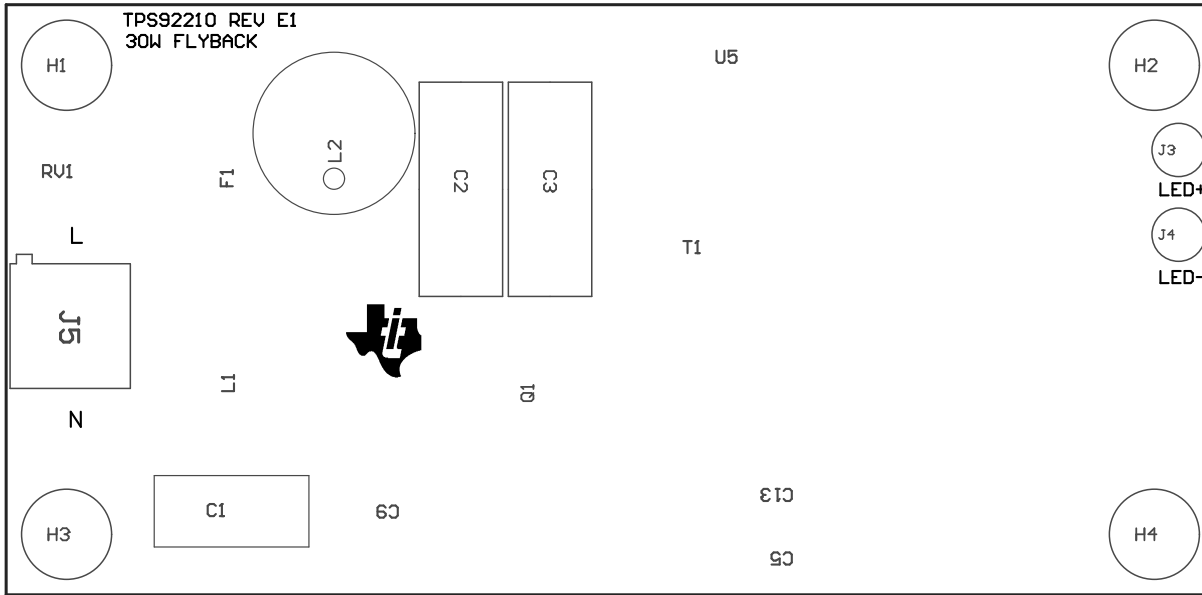
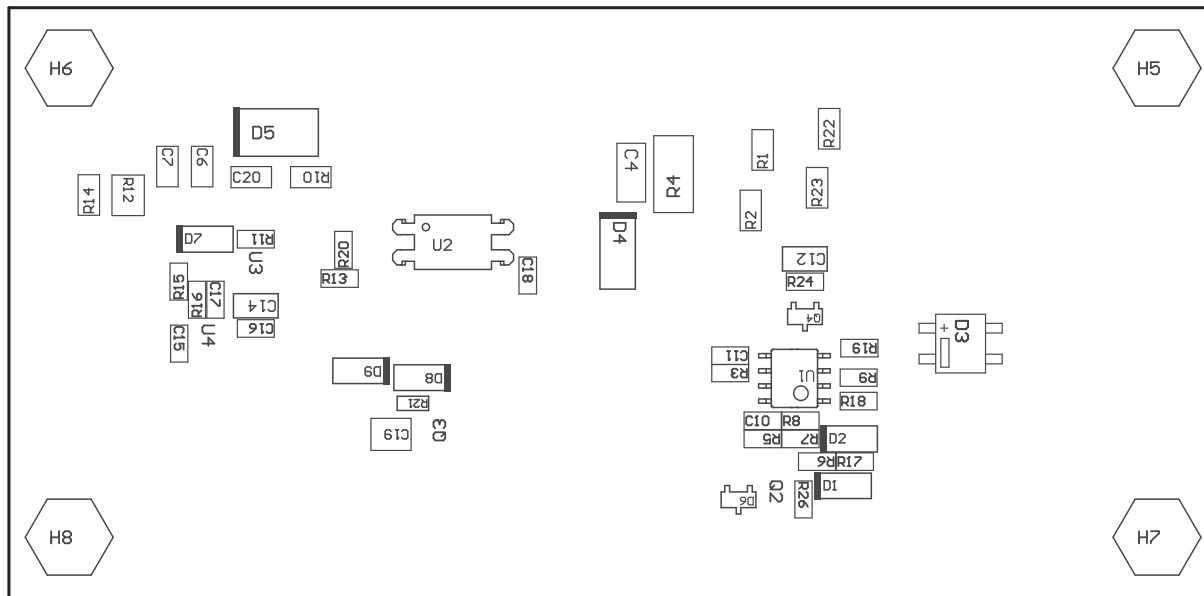


- ZZ1 ■ These assemblies are ESD sensitive, ESD precautions shall be observed.

- ZZ4 ■ Install 'C8' bent over horizontally & apply RTU167 to secure to the PCB surface, bend radius should follow best practice guidelines.
